

2024 SYDNEY ROYAL EASTER SHOW

CONDITIONS AND GUIDELINES FOR JUDGES, STEWARDS AND SHOW OFFICIALS

- 1. I am an independent person over 18 years of age who will work at the Showground on a **voluntary** basis only. I will be provided with a Duty Roster which will outline details of the tasks to be performed by me at the Showground and I will read through Officials Guidelines and comply with its contents.
- 2. In the case of Judges, in accepting this invitation, I acknowledge that;
 - i. I will not, from the time of acceptance of the position as a Judge, have any immediate family interest (including that of a de facto relationship or any other living arrangement), financial interest, commercial arrangements or any dealings, whether express or implied with any Exhibit or Exhibitor for the breed or class which I am judging.
 - ii. The Exhibitors and I have not been a guest in the other's home within the preceding 6 months.
 - iii. I will not accept like or similar judging appointments within the six month period preceding the 2024 Sydney Royal Easter Show.
- 3. I understand that to ensure the integrity of the competitions, I am not permitted to be intoxicated during the performance of my tasks and I will step aside if the RAS believes my judgement is impaired.
- 4. I acknowledge the RAS is not responsible for my personal property and the RAS is under no liability in respect of any loss or damage to my personal property.
- 5. I acknowledge that the RAS operates surveillance cameras for the safety and security of individuals and property in accordance with the Workplace Surveillance Act 2005 and adheres to the *Privacy Act* (Cth) 1988.
- 6. I agree that the RAS may disclose my name to the AGShows NSW or other related entities in relation to my work as a judge, steward or show official. My details will be dealt with in accordance to the RAS Privacy Policy located at <u>www.rasnsw.com.au</u>. I will not use any of the confidential or privileged information that I may acquire prior or during the Period in any manner that may injure or cause loss to the RAS.

- 7. I will not bring any hazardous or dangerous substances onto the Sydney Olympic Park area and I will adhere the Conditions of Entry to Sydney Showground.
- 8. I am not permitted to collect monies, sell any goods including food and beverage or distribute pamphlets, stickers or balloons. I understand that these items are not permitted at the Showground.
- 9. If there is a claim which arises out of a negligent or improper act or omission by me, I agree to indemnify the RAS against the claim. I understand that the RAS agrees to be proportionately liable to the extent that any negligent act or omission of the RAS may have contributed to the claim.
- 10. I am fit for the purpose of performing my tasks at the Showground. I have no known physical or mental condition likely to affect my performance. I will exercise reasonable care when performing my tasks in a way that ensures the health and safety of myself and others.
- 11. I will comply with the Work Health and Safety rules, operational procedures and Health and Safety requirements for my required tasks.
- 12. I will call 9704 1020 in the event of an injury, incident, or near miss that can be prevented.
