

2025 SYDNEY ROYAL EASTER SHOW - TREATMENT NOTIFICATION FORMS

Thank you for entering the 2025 Sydney Royal Easter Show. As an Exhibitor, you have agreed to comply with the RAS General Regulations, your specific Competition Regulations, and the Sydney Showground Conditions of Entry (collectively known as "the Regulations"). I wish to bring to your attention the following RAS General Regulations pertaining to Prohibited Substances:

PROHIBITED SUBSTANCE

130. A Treatment Notification Form must be:

(a) Completed if a Prohibited Substance has been administered to an Exhibit within:

(i) 180 days in the case of hormones and their synthetic counterparts, cortico steroids and anabolic steroids, and

(ii) in all other cases, 14 days, before the Day of Exhibition;

(c) Submitted to the Superintendent's office of the relevant section by 6.00pm on the day before the Day of Exhibition

Note – in the case of Dogs and Small Animals, submitted to the office no later than 8.30am on the day of judging.

131. An incomplete Treatment Notification Form may be rejected by the RAS and if that occurs, the Exhibit must not compete in any event unless, prior to that event:

(a) The Exhibit has been examined as contemplated in General Regulations 134;

(b) The Exhibitor has paid to the RAS an examination fee as determined by the relevant Committee; and

(c) Permission to compete has been given in writing by the Chairman of the Veterinary Committee or a Veterinary Surgeon.

Exhibitors must also be reminded that the RAS may, at its discretion, examine and/or take samples from any Exhibit for the purposes of detecting Prohibited Substances. Should a confirmatory test be requested by the Exhibitor, this test will be at the Exhibitor's expense.
