Risk Assessment Guidelines

All RAs as a minimum should include controls for managing the following hazards:

- Manual tasks
- Vehicle management for load in/out
- Responding to fire and emergencies
- Persons working unfamiliar temporary work area – controls to include induction, training, and supervision of workers

The following hazards should be included and controlled where present at the event:

- Crowd Risks:
 - Public attendance any event with public attendance, RA should address risk of overcrowding, high density crowds.
 - > Queuing
- Food preparation
 - > LPG storage and use
 - > Gas Appliances
 - > Food safety
 - > Allergens

- Electrical Installation
- Pyrotechnics
 - > Fireworks
 - > Cold Pyro
 - > Other special effects including haze
- Hot Works
 - > Metal Cutting and grinding
 - > Arc welding
 - > Oxy Cutting
- Temporary structures:
 - > Stages (including fall from stage)
 - > Exhibitor stands
 - Marquees (larger than 3x3m will require structural certification)
 - > Temporary fencing (to be braced and ballasted in accordance with structural certification)
 - Other temporary structure

Note: Any structural work classified under the WHS Act as 'Construction Work' must be identified, and requirements in relation to completion of General Construction Induction (White Card) training adhered to.

 - > Children (supervision and procedures for lost/missing and injured minors)
 - Persons with a disability
 - > Persons with a medical condition
- Events involving animals:

Control Measures

ELIMINATION

Remove the hazard completely. Eliminating the hazard is the most effective way to manage risks.

Where is it not practical to eliminate a hazard, risk must be minimised.

Use one or more of the following:

Engineering

Change the design

Substitute the hazard

Replace the hazard with

Isolate the hazard

Separate the hazard from people

Minimise any remaining risk by using administrative controls.

ADMINISTRATION

Health and safety procedures and policies, e.g. safe work procedures, staff training.

If risks remain, the possible impact on people must be controlled using PPE.

PERSONAL PROTECTIVE EQUIPMENT (PPE)

e.g. safety glasses, hard hats, protective clothing. This is the least effective way to manage risks.
