# SPECIAL HORTICULTURE REGULATIONS.

Exhibitors are reminded that the Society's General Regulations apply to all sections of the Show and that the Special Regulations hereunder set out which apply to this section only are merely supplementary to the General Regulations.

JUDGING WILL BE CARRIED OUT STRICTLY IN ACCORDANCE WITH THE STANDARDS OF THE ROYAL HORTICULTURAL SOCIETY OF NEW SOUTH WALES.

C. Parkes, Hon, Secretary, Royal Horticultural Society of N.S.W., 508 Twin-rd., North Ryde, N.S.W., at a cost of 5/- plus

Exhibits must be staged not later than 10 a.m. on the day exhibits are to be judged. THIS RULE WILL BE STRICTLY

After the judges have completed their awards in each session, all cut blooms shall become the property of the Society and shall be taken over by the Superintendent of the Pavilion

Labelling and Arrangement of Exhibits. Each separate variety must be labelled with its scientific or individual common name, which must be written on a card which will be supplied by the Society. Exhibits not so marked, unless they are seedlings and marked as such, will be ineligible to compete. This rule will be rigidly enforced.

Non-competitive exhibits may be shown at the discretion of the Society and or the Steward-in-Chief.

Under no circumstances shall any person canvass or book orders on the exhibits.

It shall be a condition of entry that exhibitors have become thoroughly conversant with the regulations and that they have complied with the following provisions:

- (a) that exhibits of cut blooms or other cut plant material were grown by the exhibitor either at his place of residence or on land regularly under his control for the growing of plants;
- (b) in the case of classes for plants growing in pots or other containers, such plants must be the bona fide property of the exhibitor and must have been in the possession and ownership of such exhibitor for a period not less than three calendar months immediately prior to the date of entry.

This regulation shall not apply to entries in the Decorative Section or Classes 990 to 993.

The same exhibit of Foliage Plant or Plants and Flowering Plant, or Plants is NOT eligible to win more than two prizes
